

# 2008 - 2018 Trending Information

### **Highlights of 2018 YTD M&A Activity**

- 142 transactions in Q1-2018, down from 186 in Q1-2017
- > 567 transactions in past 12 months
  - > 3<sup>rd</sup> highest of all time behind Q3 and Q4-2017
- Acrisure led all buyers with 28 transactions
  - > Followed by Hub (13), AssuredPartners (10), Alera (8), Broadstreet Partners (7) and Gallagher (6)
- As evidenced by the top Buyers, the Private Equity-Backed / Hybrid ("PE/Hybrid") group of Buyers were the lead buyer segment, completing more than 60% of the total transactions






#### Quarterly M&A Activity

#### **Observations:**

- 24% reduction in deal count from Q1-2017 not indicative of overall M&A activity
- 142 transactions in the quarter is 4th highest quarterly total, behind Q1-2017, Q2-2017 and Q4-2017
- 36 announced Private-Buyer transactions 3rd highest quarterly total
- No obvious impact from 2017 tax reform Act
- Buyers remain very aggressive on valuations, and Sellers continue to come out of the woodwork
